Exchange Individual & Family Plans: These are health insurance plans purchased on the federal health insurance exchange (www.HealthCare.gov). Depending on your household size and gross annual income, you may be eligible for premium assistance.

<u>Large Employer Plans:</u> These are group health insurance plans designed specifically for large groups of 50+ employees.

<u>Small Employer Plans:</u> These are group health insurance plans that can help small groups of typically 1-50 employees.

Short Term Health Insurance Plans: These are plans that are specifically designed for a short term, typically three years or less. Usually less expensive than "qualified health plans," with more limited benefits.

<u>Dental Insurance:</u> We have both individual and group dental insurance plans available.

<u>Vision Insurance:</u> We have both individual and group vision plans available.
